## **Regional Assembly**

We are pleased to confirm that the GEECT Regional Assembly will take place on 28th and 29th October 2025 in Guadalajara, Mexico, during the CILECT Congress. We look forward to welcoming members for two sessions of discussion, reflection, and planning for the future of our regional association.

### **GEECT Elections**

You will have received the recent communication from the Executive Director regarding the upcoming elections (see also below). All GEECT Board positions — with the exception of the Chair — will be open for election.

We strongly encourage you to consider standing for election to the Board. In particular, as the current Vice Chair/Treasurer is not eligible for re-election, it is especially important that we identify candidates with the appropriate skills and experience to take on this key role. We also hope to achieve a broad geographical and gender balance in the composition of the Board, and would welcome nominations that support this goal.

This is a kind reminder of the Unesco-supported film prize themed "Back to Our Future,"

- International screenings in Brasilia, Paris, and the 2026 World Water Forum

# PÖFF Shorts Industry Shortcut Nov. 14-15, 2025, Tallinn, Estonia

The organisers have requested to distribute information on The Shorts Industry Shortcut (SIS) which is PÖFF Shorts' industry arm, a stimulating and inspiring platform for emerging filmmakers with the aim to further the careers of future generations of filmmakers and guide them on the short film circuit.

The programme starts off with a panel on the topic of "Boutique Short Film Festivals." It will be followed by a "Festival Programming 101" with four short

film programmers demystifying the programming process, along with a speed-dating session between short film professionals and filmmakers in attendance; Go Long! Lectures bridging the gap between shorts and features, a practical short film distribution session, as well as a brand-new workshop for Estonian Emerging Producers. The two-day industry events will be rounded off with masterclasses by established filmmakers from both the animation and liveaction branches.

Case study of his film, how he got from the idea to a finished film that is currently having a very successful festival run.

#### Festival Etiquette – Do's & Don'ts

Lecture on how to get your film to a festival, how to navigate the short film festival circuit and how to make the most of your time while attending a festival (networking, taking part in industry events, pitching your projects/ideas).

#### Screening + practical exercise + discussion

Screening of short films by participants of the Estonian Emerging Producers workshop followed by a discussion and a practical exercise on how to make a distribution plan and festival strategy for one of the films screened.

#### **Accreditation Information**

All the events of PÖFF SIS are accessible only with accreditation. To film students, we offer a special Industry Student accreditation, which also gives access to all the festivals: PÖFF, PÖFF Shorts and Just Film as well as the Industry@Tallinn & Baltic Event open events.

Industry Student accreditation costs 75€ (the cost will be 100€ on Oct 1st, and 150€ from Nov 1st). The right is given only to an agreed list of students, which will be checked during the application confirmation process.
